Article 4.1 of Directive 2002/95/EC specifies the following substances, which should not be present in new electrical and electronic equipment on or after July 1st of 2006: lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE).
